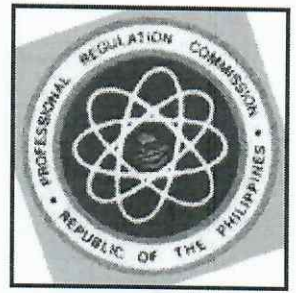

Protects up to 1TB traffic/month 5. 24/7 onsite/phone/online Customer Support <ol style="list-style-type: none"> 5.1. Shall include after office hour onsite troubleshooting of issues related to the proposed solution; 5.2. Shall have a LOCAL certified technical support personnels. 6. One-year subscription 7. Must be able to protect against all of the 2013 OWASP Top Ten and also emerging new threats including securing interactive AJAX applications and JSON payloads, brute force attacks and application Dos/DDoS as well as lower OSI layer Dos/DDoS protections. 8. Must be able to encrypt data at the application-layer 9. Must be able to generate custom or pre-defined graphical reports. The WAF solution's reports should be available on demand or scheduled 10. Must provide a comprehensive web access log 11. Must include a web based administration interface 12. Must provide security alerts that highlight the exact event that triggered the violation 13. Must provide information that shows web vulnerabilities, as well as attacks detected and blocked during customizable periods 14. Must have credit card number and social security number leakage detection capabilities 15. Must be able to detect and contain attacks attempting to conduct any virtual behavior by injecting SQL queries in requests 16. Must be able to detect and contain attacks attempting to discover vulnerabilities of a website

1. Compliance with the statements must be supported by evidence in a Bidders Bid and cross-referenced to that evidence.
