1.	SUPPLY AND DELIVERY OF HP TONERS CF237A, BLACK  1. HP Toners CF237A, Black (Genuine HP Toner)  Quantity: 40 Carts	
2.	Bidder shall submit original/certified true copy of the following documents during the opening of bids:  a. Manufacturer's Certificate as to the authenticity of the product;  b. Certificate as Authorized Reseller/Distributor;	
3.	Lowest Calculated Bidder shall present sample of offered product and shall be tested during the Post-Qualification of bids. The sample provided shall form part of the deliverables of the bidder in case the contract is awarded.	
4.	Should the item delivered is found to be defective or not authentic, the bidder shall replace the item immediately within three (3) calendar days from receipt of request for replacement.	

- Compliance with the statements must be supported by evidence in a Bidders Bid and cross-referenced to that evidence. Evidence shall be in the form of manufacturer's un-amended sales literature, unconditional statements of specification and compliance issued by the manufacturer, samples, independent test data etc., as appropriate.
- A statement that is not supported by evidence or is subsequently found to be contradicted by the evidence presented will render the Bid under evaluation liable for rejection.
- A statement either in the Bidders statement of compliance or the supporting evidence that is found to be false either during Bid evaluation, post-qualification or the execution of the Contract may be regarded as fraudulent and render the Bidder or supplier liable for prosecution subject to the provisions of ITB Clause 4.
