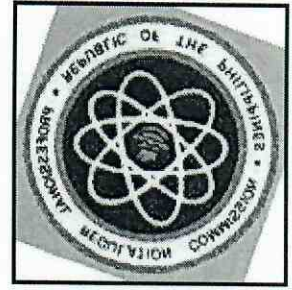

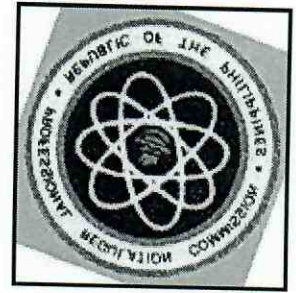

1.2	The name of the Project is PROCUREMENT OF COURIER SERVICES FOR CALENDAR YEAR 2019 FOR THE CENTRAL OFFICE TO THE FIFTEEN (15) REGIONAL OFFICES, SATELLITE OFFICES AND OFF SITE SERVICE CENTERS WITH AN APPROVED BUDGET FOR THE CONTRACT OF NINE HUNDRED THOUSAND PESOS (P900,000.00) The identification or reference number of the Contract is: ITB No. 2019-19
2	The Funding Source is the Government of the Philippines (GOP) through the General Appropriations Act of 2019.
5.1	Bidding is restricted to eligible bidders as provided by ITB clause 5.1
5.2	None of the circumstances mentioned in the ITB Clause exists in this Project. Foreign bidders, except those falling under ITB Clause 5.2 (b) , may not participate in this Project.
5.4	The Bidder must have completed, within the period specified in the Invitation to Bid and ITB Clause 12.1 a (ii) , a single contract that is similar to this Project, equivalent to at least fifty percent (50%) of the ABC. For this purpose, similar contracts shall refer to contracts for COURIER SERVICES.
5.5	The Bidder must submit a computation of its Net Financial Contracting Capacity (NFCC), which must be at least equal to the ABC to be bid, calculated as follows: NFCC = [(Current assets minus current liabilities) (15)] minus the value of all outstanding or uncompleted portions of the projects under going contracts, including awarded contracts yet to be started coinciding with the contract for this Project. The values of the domestic bidder's current assets and current liabilities shall be based on the latest Audited Financial Statements submitted to the BIR- for purposes of computing the foreign bidders' NFCC, the value of the current assets and current liabilities shall be based on their Audited Financial Statement prepared in accordance with international financial reporting standards.

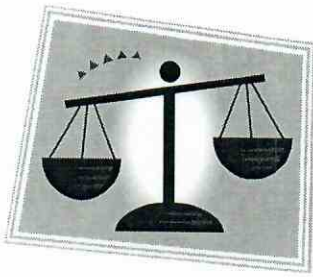

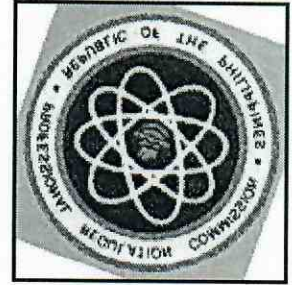

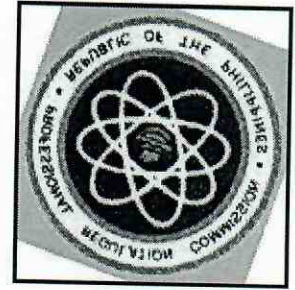

13.2 (a)	The ABC of NINE HUNDRED THOUSAND PESOS (P 900,000.00) , is <i>inclusive of all taxes and bank charges</i> . Any bid with a financial component exceeding this amount shall not be accepted and will be disqualified.
15.4 (a) (iii)	"No incidental services are required."
