**INVITATION TO BID FOR  
SUPPLY AND DELIVERY OF VARIOUS FURNITURE AND FIXTURE  
LOT 1 TO 4**

1. The **PROFESSIONAL REGULATION COMMISSION (PRC)**, through the **Government of the Philippines (GOP)**, **General Appropriations Act (GAA) of 2023 (Republic Act No. 11936)** and **Continuing Fund of 2022**, intends to apply the total sum of **Three Million Two Hundred Eleven Thousand Five Hundred Seventy-Three Pesos and Eighty Centavos (Php3,211,573.80)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Supply and Delivery of Various Furniture and Fixture Lot 1 to 4 / ITB No. 2023- 48 to 51**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **PRC** now invites bids for the **Supply and Delivery of Various Furniture and Fixture**, composed of four (4) Lots, which are as follows:

**Lot 1** – Supply and Delivery of 38 Sets of Office Table with Mobile Pedestal with Approved Budget for the Contract of One Million Seventy-Nine Thousand Seven Hundred Six Pesos and Fifty-Four Centavos (Php1,079,706.54) - (ITB No. 2023 – 48)

**Lot 2** – Supply and Delivery of 6 Sets of Executive Table with Mobile Pedestal with Approved Budget for the Contract of Two Thousand Twenty-Nine Thousand Two Hundred (Php229,200.00) - (ITB No. 2023 – 49)

**Lot 3** – Supply and Delivery of 180 Units of Executive Chairs with Approved Budget for the Contract of One Million Eight Hundred Eighty-Nine Thousand Four Hundred Pesos and Sixty Centavos (Php1,889,400.60) - (ITB No. 2023-50)

**Lot 4** – Supply and Delivery of 2 Units of Three-Layer Computer Desk with Approved Budget for the Contract of Thirteen Thousand Two Hundred Sixty-Six Pesos and Sixty-Six Centavos (Php13,266.66) - (ITB No. 2023-51)

The said project shall be completed within the duration of indicated in the Schedule of Requirements from the date of receipt of Notice to Proceed. Bidders should have completed, within the period from January 2019 up to the date of submission and opening of bids, a contract equivalent to at least fifty percent (50%) of the ABC that is similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Prospective bidders may obtain further information from **PRC** and inspect the Bidding Documents at the address given below during **office hours**.

5. A complete set of Bidding Documents may be acquired by interested Bidders from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of :

**Lot 1 – Five Thousand Pesos (Php5,000.00)**

**Lot 2 – Five Hundred Pesos (Php500.00)**

**Lot 3 – Five Thousand Pesos (Php5,000.00)**

**Lot 4 – Five Hundred Pesos (Php500.00)**

The applicable fees paid previously for the same project may be used by the same bidder if the declaration of failure of bidding is pursuant to Section 41. Reservation Clause of RA 9184.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The **PRC** will hold a Pre-Bid Conference at **9:30 AM of September 28, 2023** through video conferencing, which shall be open to prospective bidders. For proper coordination, all interested bidders are hereby requested to submit their Letter of Intent to participate, including therein contract details, and send to [bac@prc.gov.ph](mailto:bac@prc.gov.ph) on or before September 27, 2023.
7. Bids must be duly received by the Bids and Awards Committee (BAC) Secretariat through manual submission at the address indicated below on or before **9:00 AM of October 11, 2023**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in the form of a Bid Securing Declaration.
9. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity via video conferencing. Bid opening shall be at the **BAC Conference Room, 4<sup>th</sup> Floor, PRC Annex Building, P. Paredes St., Sampaloc, Manila** at:
