**RESOLUTION NO. 1408**

**CANCELLING THE AUGUST 2021 LICENSURE EXAMINATION FOR  
ARCHITECTS IN THE NATIONAL CAPITAL REGION**

**WHEREAS**, Section 7 (d) of Republic Act No. 8981 or the “PRC Modernization Act of 2000” empowers the Professional Regulation Commission (Commission) to administer and conduct the licensure examinations of the various regulatory boards in accordance with the rules and regulations it may promulgate and to determine and fix the places and dates of examinations;

**WHEREAS**, the Commission issued Resolution No. 1283 (s. 2020) scheduling the licensure examinations for calendar year 2021 wherein the Licensure Examinations for Architects (LEA) are scheduled on January 29 & 31, 2021 and June 25 & 27, 2021 to be held in National Capital Region (NCR), Baguio, Cebu, Davao, Legaspi, Lucena, Pampanga, and Zamboanga;

**WHEREAS**, the Commission issued Resolution No. 1297 (s. 2021) postponing the January 2021 LEA to June 2021. However, the June 2021 LEA was later postponed and rescheduled to August 27 & 29, 2021 per Resolution No. 1365 (s. 2021);

**WHEREAS**, Tacloban and Iloilo were designated as additional testing centers pursuant to Resolution Nos. 1355 (s. 2021) and 1369 (s. 2021), respectively;

**WHEREAS**, in as much as all face-to-face non-emergency essential government activities are suspended in Davao until August 31, 2021, the Commission pursuant to Resolution No. 1388 (s. 2021) cancelled the August 2021 LEA in Davao and opened Koronadal as an additional testing center upon approval thereof by the City of Koronadal;

**WHEREAS**, Inter-Agency Task Force (IATF) Resolution No. 119 (s. 2021), provisionally approved the Commission to conduct the July to September 2021 licensure examinations, subject to the strict monitoring and observance of minimum public health standards and health and safety protocols of the Commission and subject to the issuance of the PRC-DOH-PNP Joint Guidelines, and the community quarantine classification as the IATF may implement on certain provinces, highly urbanized cities, and independent component cities.

**WHEREAS**, on August 19, 2021, the Office of the President, pursuant to IATF Resolution No. 134 (s. 2021), declared the NCR under Modified Enhanced Community Quarantine (MECQ) classification starting August 21 until August 31, 2021;

**WHEREAS**, the areas placed under MECQ shall observe the following protocols<sup>1</sup>, among others:

1. The movement of all persons shall be limited to accessing goods and services from permitted establishments, for work in such establishments, or for such other activities allowed in this section. (As amended by Paragraph C of IATF Resolution No. 110, April 15, 2021);
2. Gatherings outside of residences shall be prohibited. Gatherings at residences with any person outside of one’s immediate household shall likewise be prohibited. However, gatherings that are essential for the provision of health services, government services, or humanitarian activities authorized by the appropriate government agency or instrumentality shall be allowed.;
3. The following establishments, persons, or activities shall not be permitted to operate, work, or be undertaken during MECQ: Venues for meetings, incentives, conferences, and exhibitions; and
4. Face-to-face or in-person classes shall be suspended;

**WHEREAS**, adhering to the guidelines of the national government to address the COVID-19 pandemic and considering the travel restrictions and health protocols adopted under MECQ, the Professional Regulatory Board of Architecture and the Licensure Office recommend to the Commission the cancellation of the conduct of the August 2021 LEA in the NCR.

**WHEREFORE**, in view of the foregoing, the Commission **RESOLVES**, as it hereby **RESOLVED**, to **CANCEL** the conduct of the **August 27 & 29, 2021 Licensure Examinations for Architects in the NCR**.

**RESOLVED FURTHER**, that the Licensure Examination for Architects shall proceed in **Baguio, Cebu, Koronadal, Iloilo, Legaspi, Lucena, Pampanga, Tacloban, and Zamboanga** on August 27 & 29, 2021.

**RESOLVED FINALLY**, that the affected examinees in the NCR may take the next succeeding examination without forfeiture of their examination fees.
