RESOLUTION NO. 1631 Series of 2023

REMOVING CALAPAN CITY AS A TESTING CENTER FOR LICENSURE EXAMINATIONS SCHEDULED FROM APRIL TO JUNE 2023

WHEREAS, Section 7 (d) of Republic Act No. 8981 or the "PRC Modernization Act of 2000" empowers the Professional Regulation Commission (PRC/Commission) to administer and conduct the licensure examinations of the various regulatory boards in accordance with the rules and regulations it may promulgate, and to determine and fix the places and dates of examinations;

WHEREAS, the Commission issued Resolution No. 1589 (s. 2022) designating Calapan City as a testing center for various licensure examinations;

WHEREAS, the PRC Regional Office IVB-MIMAROPA (PRC RO IV-B), in its 02 March 2023 Memorandum, requested for the cancellation of the conduct of Licensure Examinations for Pharmacists, Electronics Engineers, Electronics Technicians, Civil Engineers, Registered Electrical Engineers, Registered Master Electricians, Certified Public Accountants, Nurses, Architects, Psychologists, and Psychometricians;

WHEREAS, PRC RO IV-B just recently transferred to their new office and is currently facilitating the installation of the Internet Protocol Virtual Private Network (IP/VPN) for their Confidential Printing Room;

WHEREAS, considering the aforementioned reason, the Professional Regulatory Boards concerned, the Licensure Office, and the Licensure Division recommend to the Commission the cancellation of the conduct of the various licensure examinations from April to June 2023 in Calapan City.

WHEREFORE, in view of the foregoing, the Commission RESOLVES, as it hereby RESOLVED, to REMOVE Calapan City as a testing center in the conduct of the following licensure examinations:

- 1. April 2023 Pharmacists
- 2. April 2023 Electronics Engineers
- 3. April 2023 Electronics Technicians
- 4. April 2023 Civil Engineers
- 5. April 2023 Registered Electrical Engineers
- 6. April 2023 Registered Master Electricians
- 7. May 2023 Certified Public Accountants
- 8. May 2023 Nurses
- 9. June 2023 Architects
- 10. June 2023 Psychologists
- 11. June 2023 Psychometricians

All Commission offices/divisions are enjoined to undertake the necessary coordination to ensure the smooth and orderly conduct of the licensure examination.
