**FISHERIES TECHNOLOGIST LICENSURE EXAMINATION RESULTS  
RELEASED IN THREE (3) WORKING DAYS**

The Professional Regulation Commission (PRC) announces that **52** out of **220** passed the Fisheries Technologist Licensure Examination given by the **Board of Fisheries** in **Manila, Davao, Iloilo** and **Legazpi** this **October 2009**.

The members of the Board of Fisheries are **Rogelio O. Juliano**, Chairman; **Cesario R. Pagdilao** and **Catalino R. Dela Cruz**, Members.

The results were released in three (3) working days after the last day of examination.

**Seventeen (17)** applicants were approved for registration without examination as Fisheries Technologists.

Registration for the issuance of Professional Identification Card (ID) and Certificate of Registration will start on Tuesday, November 3, 2009 but not later than November 20, 2009. Those who will register are required to bring the following: duly accomplished Oath Form or Panunumpa ng Propesyonal, current Community Tax Certificate (cedula), 2 pieces passport size picture (colored with white background and complete nametag), 1 piece 1" x 1" picture (colored with white background and complete nametag), 2 sets of metered documentary stamps, and 1 short brown envelope with name and profession; and to pay the Initial Registration Fee of ₱600 and Annual Registration Fee of ₱450 for 2009-2012, and to pay the Examination Fee of ₱900 for applicants for registration without examination. **Successful examinees should personally register and sign in the Roster of Registered Professionals.**

The oath-taking ceremony of the successful examinees in the said examination as well as the previous ones who have not taken their Oath of Professional and those who registered without examination will be held before the Board on Monday, November 30, 2009 at 1:00 o'clock in the afternoon at the Manila Hotel, One Rizal Park, Manila.
